Subject: Requirement of officers in NTP Circle.

It is intimated that NTP Circle has been assigned with the responsibility of successful implementation of NFS Project which is a nation wide Optical Fiber Network of 60,000 Kms (57,000 Kms for Army and 3,000 Kms for Navy). NTP Circle has been allotted 26,682 route Kms which is almost equal to 50 % share of the total route Kms of Army Network. NFS Project is a Turnkey Project and with a strict completion time line of 18 months from the date of issue of Purchase Order.

It is further intimated that the purchase order for Package-'A' (of 9495 Kms covering J&K area) & 'B' (of 7599 Kms covering Punjab, Haryana, Himachal Pradesh & NCR area) were issued in the last week of July-2014 and purchase order for Package-'C' (of 9568 Kms covering UP, Rajasthan & Uttarakhnad area) is likely to be issued by BSNL C.O. in this week.

As you will appreciate that the task assigned to NTP Circle is huge and requires considerable amount of man power for adhering to the completion time lines of 18 months.

There is an acute shortage of man power in NTP Circle. It is therefore requested to spare some willing JTOs/SDEs for associating them with NFS Project in NTP Circle on temporary transfer basis till the execution/completion of NFS Project. Willingness of officers may kindly be taken and list of willing officers may be sent to the under signed at earliest so that their case for temporary transfer in NTP Circle for NFS Project can be taken up with BSNL Corporate Office on top priority.
