Sub: LICE held on 02-06-2013 for promotion to the cadre of JTO (T) against 35% & 15% quota for the Vacancy Year 2001-02 to 2012-13 -Announcement of results thereof.

In pursuance of BSNL Corporate Office, New Delhi letter No. 22-24/2012-Rectt. dated 14/01/2013 and CGMT HP Circle letters No. HRD/R&E/Ex-271/LICE/JTO (35% and 15% Quota)/27 dated 20/02/2013 and No.89 dated 27/07/2013, the result of LICE for promotion to the grade of JTO (T) under 35% quota for vacancies from 2001-02 to 2012-13 held on 02/06/2013 is hereby declared. None of the official has applied under 15% quota.

The result is declared as per BSNL guidelines contained in BSNL Corporate Office letter referred above on the basis of merit against the eligibility year of candidates. The name of the candidates, who have been declared successful for promotion to the cadre of JTO (T), are detailed in **Annexure-A** enclosed.

The result is purely provisional and BSNL reserves the right to cancel/modify the result of any candidate declared successful by mistake/inadvertently at any time whenever such mistake is noticed/detected.

No request received after 30-09-2013 shall be entertained under any circumstances.

The selected candidates before appointment shall have to successfully undergo training for such period as may be specified from time to time by the BSNL. The official who fails to complete the training successfully will not be promoted/appointed as Junior Telecom Officer. Orders for pre-appointment training of selected candidates will be issued separately.



The result is further subject to outcome of OA No. 486/HP/2013 of Hon'ble CAT Bench, Chandigarh.

The Heads of the SSAs/Units should ensure that no disciplinary /vigilance case is pending against the officials before relieving them for training.

All units are requested to give this result wide publicity for information of all concerned.
